# **Campaign Updates (Kelli Byrd)**

- Meeting with Statewide Chair. Kelli mentioned there was a successful meeting with the
  Statewide Chair, Lt Governor Susan Bysiewicz. In attendance was Kelli Byrd, Tim Newton, Peggy
  Gray, and representatives from the PCFO. Kelli and Tim mentioned the support we have from
  the LG and the additional ways that she would get involved with this year's campaign, one
  including attending and speaking at the statewide kickoff event.
- Hartford Yard Goats. Kelli mentioned how the Yards Goats game was a success. Over 425 state employees attended the event bringing great visibility to the campaign.
